 - b. become a party to any contract between the Project Sponsor and Customer.
- G. I understand that the Project Sponsor is an independent contractor and is not authorized to make any representations or incur any obligations on behalf of Frontier Energy or TNMP. I acknowledge that Frontier Energy and TNMP are not a party to the Host Customer Agreement and that Project Sponsor is solely responsible for performance thereunder.
